Mr. Inglesino also has a distinguished record of public service. From 2012 - 2018, he served as a member of the Board of Trustees of the New Jersey Public Broadcast Authority, having been appointed by Governor Chris Christie.

As a Freeholder, Mr. Inglesino served as Freeholder liaison to various County departments and agencies. He served as chairman of the Morris County Insurance Fund. Mr. Inglesino is the former Mayor of Rockaway Township, Morris County, New Jersey (1996-2002) and former Rockaway Township Councilman (1994-1995).
